Main Components of Extension Approved by the Dept. of Education:

Standard sized multi-purpose room

- + 4 x classrooms
- + Remedial room
- + 5 x resource rooms
- + Room to house a small library
- + General storage rooms

= approx €2m

Additional Elements, which An Mhodscoil must Fund:

Multi-purpose room upgrade to Sports Hall

- + Astro-turf playing area
- + Music room equipment
- + Language laboratory
- + Computer enhancements

= approx €1m

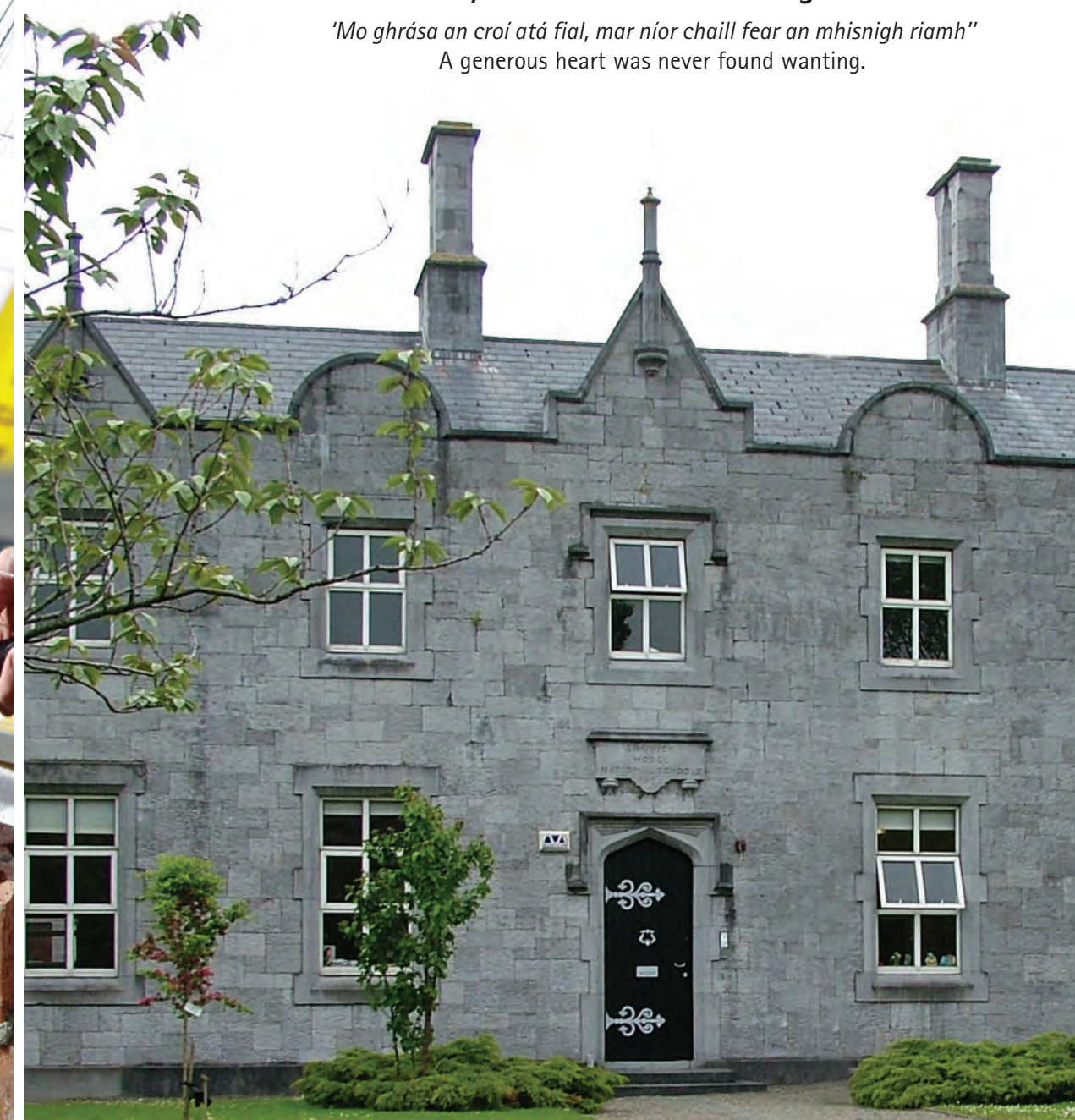

A Big Effort ...

... is needed to secure the estimated €1m required to complete the school extension to our desired standard.

This is why we are asking friends of *Modhscoil Luimnigh* to share the burden.

Moreover, we need long term commitments of funding.

Greatly improved sports, learning and recreation facilities will open up new learning experiences for the pupils of *Modhscoil Luimnigh* during their formative years.

Contributors to the school expansion programme can forever take pride in the knowledge, that they will have made it possible for *Modhscoil Luimnigh* to continue its 150-year-old tradition as an innovator in education.

The availability of tax relief on both individual and corporate donations means that *Modhscoil Luimnigh* can benefit from up to 60% in tax returns on all personal donations of €250 or over in any calendar year (e.g. a €250 donation from a PAYE worker is eligible for up to €174 in tax returns for the school, in effect increasing the value of the initial donation to €424.)
